**WAIVER AND RELEASE OF ALL CLAIMS**

**Activity: Kendall County Fair Mud Volleyball Tournament:** The Kendall County Fair Association is committed to conducting recreation programs and activities in a safe manner, and hold the safety of the participants in high regard. We strive to reduce risks, and insist that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this activity must recognize that there is an inherent risk of injury when choosing to participate. You are solely responsible for determining if you or your minor child/ward are physically fit/and or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way, or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

**Warning of Risk:** Mud Volleyball is an activity that challenges and engages the physical, mental and emotional resources of each participant. However, despite careful and proper preparation and instruction, there is still a risk of serious injury. Understandably, not all hazards and dangers can be foreseen, including but not limited to overexertion, dehydration, slip and fall, collision with other participants, the effects of weather, lack of good physical conditioning, and all other circumstances inherent to the sport of mud volleyball. In this regard it must be recognized that it is impossible to guarantee absolute safety.

**Waiver and Release of All Claims and Assumption of Risk:** Please read this form carefully and be aware that participating in this activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program/activity. I recognize and acknowledge that there are certain risks of physical injury to participants in this activity, and I voluntarily agree to assume the full risk of any injuries, damages, or loss, regardless of severity that my minor child/ward or I may sustain as a result of participating in any and all activities connected with or associated with this program/activity. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this activity against the aforementioned.

I do hereby fully release and forever discharge the Kendall County Fair Association and the Board of Directors from any and all claims for injuries, damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in anyway associated with this program/activity. I have read and fully understand the above important information, warning of risk, assumption of risk, and waiver and release of all claims.
